

Unexpected Horrors

It all began in February of 2010 in West Philadelphia where **Kermit Gosnell** and his wife, **Pearl**, owned and operated an abortion clinic unabated for more than 30 years. Then...

- Without warning the FBI raided Gosnell's abortion business under the suspicion that he was a prescription drug dealer.

- Here's what law enforcement personnel found the night of the raid:

"There was blood on the floor. A stench of urine filled the air. A flea-infested cat was wandering through the facility and there were cat feces on the stairs. Semi-conscious women scheduled for abortion were moaning in the waiting room or the recovery room, where they sat on dirty recliners covered with blood-stained blankets."

- They also found parts and pieces of unborn children haphazardly stored in bags, milk jugs, orange juice cartons and even in empty cat food containers. Some aborted remains were found in a refrigerator right alongside employee lunches. A fully-intact baby boy estimated at 28 weeks gestational age was found frozen in a 1-gallon water jug. In the rat-infested basement investigators found jars containing just the severed feet of unborn children. They were lined up neatly in a row, like trophies on a shelf. All in all, investigators found the remains of an estimated **47** aborted babies, some dating back 30 years!

- Conditions were so barbaric that when law enforcement officials returned to collect additional evidence, they came equipped with biohazard suits including breathing apparatuses!

- Kermit Gosnell specialized in late-term abortions. He had perfected the illegal practice of "live birth" abortion. When Gosnell found it too difficult to destroy a **LATE TERM** child **IN** the womb, he would simply force premature birth; then kill the baby **OUTSIDE** the womb.

- According to a 261-page grand jury indictment:

"...he regularly and illegally delivered live, viable, babies in the third trimester of pregnancy and then murdered these newborns by severing their spinal cord with scissors."

- Gosnell affectionately referred to this unspeakable atrocity as "snipping." According to eyewitness testimony, "One premature infant wriggled around on the counter for 20 minutes before an untrained worker slit his neck -- after first playing with him."

- Only God knows what took place in this "house of horrors" on Sundays. The Lord's day was reserved for "the really big ones." Only Gosnell and his wife, Pearl, were present. He would then take medical records home and either alter them or destroy them completely.

- Neither Gosnell nor a single person on his staff were properly licensed. His murderous crew even included a 15-year-old high school student.

In April of 2013, Gosnell, his wife and a number of his employees were finally in a court of law. Eyewitness testimony indicated that Gosnell had killed well over **100** newborn infants, forced to a premature birth and then brutally murdered. Kermit Gosnell is the greatest serial killer in the history of the United States of America!

Gosnell was found guilty of three counts of first-degree murder for killing babies born alive and guilty of involuntary manslaughter in the botched abortion of Karnamaya Mongar. Gosnell was also convicted of **HUNDREDS** of lesser charges.

In a plea bargain with prosecutors, there was no opportunity for appeal. The 72-year-old Gosnell was then sentenced to serve three consecutive life sentences without the chance of parole.

Ironically, the FBI ended up at Gosnell's front door, not because of these unspeakable atrocities, but instead to make a routine drug bust. The point is...Gosnell got caught totally by accident!
