# You have a choice: Vaccine or Medicine?

We urge you to listen to the testimony of vaccine expert, Geert Vanden Bossche, who pleaded with the government to stop this "insane vaccination campaign" IMMEDIATELY! He is fearful of future consequences from the vaccine.

If you choose not to get the vaccine, you can purchase the medicine before getting the virus. Then if you get the virus, you can take the medicine and you will have a natural immunity without the complications from the vaccine. We believe that if you do that, the possibility of suffering or dying from the virus or vaccine is much less and you will have established a natural immunity. The medicine is good for other flus and viruses, also.

There are two common medicines that have been used around the world for about forty years with few, if any, side effects. They are Hydroxychloroquine and Ivermectin, both should be taken with zinc and vitamin D3 and a multivitamin. They are available by computer at frontlinemedicaldoctors.com or corsination.com and prescribed through doctors in Florida. The cost is around \$100 which includes a phone consultation.

Another less expensive option that can be bought at local farm stores is Ivermectin for horses. It comes in a paste and costs about \$5.00 per tube. You can take it by putting it on a spoon and then licking it off. You take it according to your weight and each tube will give you three or four doses. There is an adjustment on the tube in fifty pound increments, for getting the right dose for your weight. If your weight is between adjustment marks, go to the next higher mark. Some tubes have 250 lb. increments and others have 50 lb. The 50 lb. increment works best for human measurement. A common practice is to take it two days in a row, skip two days, and take it one more time. We are told that if you are unable to take it internally, you can rub it on your leg and it will go through your skin and work that way, also. We don't personally know of anyone who has done it

We know of about 40 people who have used it, some seriously ill, Ron and other family members included. Everyone has recovered with no obvious side effects. Groeninks Elevator in Nunica has a variety of brands on their horse wormer shelf that you can choose from. Make sure you get Ivermectin paste 1.87% for horses only and not with other ingredients added, except for apple flavor.

Tractor Supply stores also sell it. They keep it under the counter by the cash register. Some TSC managers discourage people from buying it for human use and have even said that people have died from using it. We have not heard of that and don't believe it to be true. The exception may be a person that did not follow the right directions or use common sense.

The problem is the pharmaceutical industry would rather sell costly unproven vaccines with no liability to the government instead. They have a lot of money and influence and have put tremendous pressure against the use of inexpensive medicines that do not provide them with a profit. When President Trump was talking positively about these medicines, they were able to shut him up, not easy to do! There are other remedies that have been suppressed, also.

This is sincere advice from a husband and wife with many years of experience and resources to draw on. We are taking the risk of being sued or persecuted for sharing this against the possibility that this information may save somebody's life!

article on the topic. All my friends had not heard

most of the details I shared, so I figured you might appreciate hearing some of what I told them. Knowing how contentious this issue is, part of me would rather just write about something else, but I feel like the discussion/news is so one-sided that I should speak up. As I always strive to do,

I promise to do my best to be level-headed and non-hysterical. I'm not here to pick a fight with anyone, just to walk you through some of what I've read, my lingering questions, and explain why I can't make sense of these covid vaccines.

## THREE GROUND RULES FOR DISCUSSION

If you care to engage on this topic with me, ex-

cellent. Here are the rules...I am more than happy to correspond with you if...

 You are respectful and treat me the way you would want to be treated.

 You ask genuinely thoughtful questions about what makes sense to you.

 You make your points using sound logic and don't hide behind links or the word "science." In other words, make a kind, level-headed argument (links welcome), but don't just post a link and say "read the science." That's intellectually lazy.

 If you do respond, and you break any of those rules, your comments will be ignored/deleted.

With that out of the way, let me say this... I don't know everything, but so far no one has been able to answer the objections below. So here are the reasons I'm opting out of the covid vaccine.

# **#1: VACCINE MAKERS ARE IMMUNE FROM**

The only industry in the world that bears no liability for injuries or deaths resulting from their products, are vaccine makers. First established in 1986 with the National Childhood Vaccine Injury Act, and reinforced by the PREP Act, vaccine makers cannot be sued, even if they are shown to be negligent.

The covid-vaccine makers are allowed to create a one-size-fits-all product, with no testing on sub-populations (i.e. people with specific health conditions), and yet they are unwilling to accept any responsibility for any adverse events or deaths their products cause.

If a company is not willing to stand behind their product as safe, especially one they rushed to market and skipped animal trials on, I am not willing to take a chance on their product. No liability. No trust. Here's why...

#### #2: THE CHECKERED PAST OF THE VAC-**CINE COMPANIES**

The four major companies who are making these covid vaccines are/have either:

1. Never brought a vaccine to market before covid (Moderna and Johnson & Johnson).

2. Are serial felons (Pfizer, and Astra Zeneca).

3. Are both (Johnson & Johnson).

Moderna had been trying to "Modernize our RNA" (thus the company name)--for years, but had never successfully brought ANY product to market--how nice for them to get a major cash infusion from the government to keep trying.

In fact, all major vaccine makers (save Moderna) have paid out tens of billions of dollars in damages for other products they brought to market when they knew those products would cause injuries and death--see Vioxx, Bextra, Celebrex, Thalidomide, and Opioids as a few examples.

If drug companies willfully choose to put harmful products in the market, when they can be sued, why would we trust any product where they have NO liability?

In case it hasn't sunk in, let me reiterate...3 of the 4 covid vaccine makers have been sued for products they brought to market even though they knew injuries and deaths would result.

- Johnson & Johnson has lost major lawsuits in 1995, 1996, 2001, 2010, 2011, 2016, 2019 (For what it's worth, J&J's vaccine also contains tissues from aborted fetal cells, perhaps a topic for another discussion.)
- Pfizer has the distinction of the biggest criminal payout in history. They have lost so many lawsuits it's hard to count. You can check out their rap sheet here: (www.mp-22.com/vax). Maybe that's why they are demanding that countries where they don't have liability protection put up collateral to cover vaccine-injury lawsuits: (www.wionews. com/world/how-pfizer-tried-to-bully-argentinaand-brazil-in-exchange-for-vaccines-366037).
- · Astra Zeneca has similarly lost so many lawsuits it's hard to count. Here's one (https://www. justice.gov/opa/pr/pharmaceutical-giant-astrazeneca-pay-520-million-label-drug-marketing). Here's another (https://www.reuters.com/article/us-astrazeneca-texas-lawsuits-idUSKBN1K-T0Q9)...you get the point. And in case you missed it, the company had their covid vaccine suspended in at least 18 countries (https://www.businessinsider.com/astrazeneca-covid-vaccine-countriessuspend-denmark-thailand-batch-blood-clots-2021-3?op=1) over concerns of blood clots, and they completely botched their meeting with the FDA with numbers from their study that didn't match (https://thehighwire.com/videos/astrazeneca-vaccine-falls-from-grace/).
- Oh, and apparently J&J (whose vaccine is approved for "Emergency Use" in the US) and Astrazenca (whose vaccine is not approved for "Emergency Use" in the US), had a liftle mix up in their ingredients...in 15 million doses (https:// childrenshealthdefense.org/defender/johnson-johnson-astrazeneca-covid-vaccine-ingredient-mix-up/). Oops.

### Let me reiterate this point:

Given the free pass from liability, and the checkered past of these companies, why would we assume that all their vaccines are safe and made completely above board? Where else in life would we trust someone with that kind of reputa-

To me that makes as much sense as expecting a remorseless, abusive, unfaithful lover to become a different person because a judge said deep down they are a good person. No. I don't trust them. -No liability. No trust!

#### Here's another reason why I don't trust them. #3: THE UGLY HISTORY OF ATTEMPTS TO MAKE CORONAVIRUS VACCINES

There have been many attempts to make viral vaccines in the past that ended in utter failure, which is why we did not have a coronavirus vaccine in 2020.

In the 1960's, scientists attempted to make an RSV (Respiratory Syncytial Virus) vaccine for infants. In that study (https://www.nature.com/ articles/s41579-020-00462-y#Sec11), they skipped animal trials because they weren't necessary back

In the end, the vaccinated infants got much sicker than the unvaccinated infants when exposed to the virus in nature, with 80% of the vaccinated infants requiring hospitalization, and two of them died (https://www.nature.com/articles/ s41579-020-00462-y#Sec11).

After 2000, scientists made many attempts to create coronavirus vaccines. For the past 20 years, all ended in failure because the animals in the clinical trials got very sick and many died, just like the children in the 1960's. • In 2012 the ferrets (https://www.ncbi.nlm.nih. gov/pmc/articles/PMC3335060/) became sick and died. And in this study mice and ferrets developed lung disease (https://www.ncbi.nlm.nih. gov/pmc/articles/PMC3335060/).

• In 2016 this study also produce lung disease in mice (https://www.tandfonline.com/doi/full/1 0.1080/21645515.2016.1177688?scroll=top&need-

The typical pattern in the studies mentioned above is that the children and the animals produced beautiful antibody responses after being vaccinated. The manufacturers thought they hit the jackpot. The problem came when the children and animals were exposed to the wild version of the virus.

When that happened, an unexplained phenomenon (https://science.sciencemag.org/content/303/5660/944.abstract) called Antibody Dependent Enhancement (ADE) also known as Vaccine Enhanced Disease (VED) occurred where the immune system produced a "cytokine storm" (i.e. overwhelmingly attacked the body), and the children/animals died. Here's the lingering issue...

The vaccine makers have no data to suggest their rushed vaccines have overcome that problem. In other words, never before has any attempt to make a coronavirus vaccine been successful, nor has the gene-therapy technology that is mRNA "vaccines" been safely brought to market, but hey, since they had billions of dollars in government funding, I'm sure they figured that out. Except they don't know if they have...

#### #4: THE "DATA GAPS" SUBMITTED TO THE FDA BY THE VACCINE MAKERS

When vaccine makers submitted their papers to the FDA for the Emergency Use Authorization (Note: An EUA is not the same as a full FDA approval), among the many "Data Gaps" they reported was that they have nothing in their trials to suggest they overcame that pesky problem of Vaccine Enhanced Disease.

They simply don't know--i.e. they have no idea if the vaccines they've made will also produce the same cytokine storm (and deaths) as previous attempts at such products.

As Joseph Mercola points out...

"Previous attempts (https://www.statnews. com/2017/01/10/moderna-trouble-mrna/) to develop an mRNA-based drug using lipid nanoparticles (https://articles.mercola.com/ sites/articles/archive/2021/02/10/nanoparticles-in-moderna-vaccine.aspx) failed and had to be abandoned because when the dose was too low, the drug had no effect, and when dosed too high, the drug became too toxic. An obvious question is: What has changed that now makes this technology safe enough for mass use?"
