Democrat Administration injects Black People with Syphilis Tuskegee – 1932

Let's take a look at what happened back in Tuskegee in 1932. A Democrat administration under FDR offered Black People "treatment" for "bad blood."

In reality, they were injecting Black People with Syphilis and refusing to offer treatment – leaving them to suffer and die.

Let's go straight to the CDC report:

In 1932, the USPHS, working with the Tuskegee Institute, began a study to record the natural history of syphilis. It was originally called the "Tuskegee Study of Untreated Syphilis in the Negro Male" (now referred to as the "USPHS Syphilis Study at Tuskegee"). The study initially involved 600 Black men – 399 with syphilis, 201 who did not have the disease. Participants' informed consent was not collected. Researchers told the men they were being treated for "bad blood," a local term used to describe several ailments, including syphilis, anemia, and fatigue. In exchange for taking part in the study, the men received free medical exams, free meals, and burial insurance.

By 1943, penicillin was the treatment of choice for syphilis and becoming widely available, but the participants in the study were not offered treatment.

Under a Democrat administration, in exchange for injecting the "Negro Male" with Syphilis, they were offered nothing more than lies and a plot to go die in.

This is what medical mandates look like under the Democrats.

Radiation Experiments, 1960-1961

In 1960-1961, poor black cancer patients were blasted with radiation as an experiment to determine "how much radiation the human body could take."

We were guinea pigs being blasted with toxic radiation to determine what it would take to kill us.

Agent Orange Trials, 1965-1966
