

## A New Revolution in Medicine

“The number of U.S. adults who place confidence in medical scientists to act in the best interests of the public declined from 40% in 2020 to 29% in 2022, according to Pew Research. A 2021 survey by the American Board of Internal Medicine likewise found that one in six people—including physicians—no longer trust doctors, and one in three do not trust the health care system. Almost half the population does not trust our public health agencies to act in our interests.” (Quoted from The Epoch Times Sept. 4-10, 2024 issue)

The medical system has turned to managerialism—the “belief that everything can and should be deliberately engineered and managed from the top down. Managerialism is destroying good medicine.” It’s like ‘one size fits all’ no matter who or what the circumstances are, and no matter what the doctor feels is best to treat you, they must follow protocol.

To be effective, the practitioner needs to make sense of the problems which requires intuition and imagination; which no machine is able to do like a human. “Medicine has always been hierarchical, but never has it been so conformist.” This was very clear when we encountered the Covid pandemic. The doctors were given ‘guidelines’ of using ventilators and Remdesivir. If the doctor felt there was something better to treat it, they were chastised. In some cases the doctors automatically turned to Ivermectin for treating the virus as they had done in previous years. They saved many lives and patients went home from the hospital, doctors’ offices, etc. At the same time the people who were treated with ventilators and Remdesivir became sicker and weaker, developed pneumonia, and many never recovered. When you have this managerialist system in American Medical Association, the doctors’ options are limited and they feel the oath they took to “do no harm” was not a choice but was actually killing people.

The same situation happened when pushing for everyone to get the Covid injections (they don’t qualify as “vaccines”) and all the ‘boosters’ they required thereafter. Most people who got the shots ended up with the virus anyway and the down side, in particular, was the reduction of your natural immune system to fight off anything else. The first shot was designed to tell your immune system ‘to go to sleep’ and you lost 50% of your ability to fight off other diseases or weaknesses in your body. If you had dormant cancer cells, many people found it came back with a vengeance. Worldwide respected Dr. John Campbell found there were 17 million EXCESS DEATHS, and turbo-cancers were up 330% between 2021-2023, in addition to heart problems, nervous system injuries, and many other life-ending illnesses. This was a example of managerialism as a protocol. One source suggested that as much as 83% of Americans received at least the first shot. The shots after that, people were less inclined to get. Remember the Nuremberg Code which says a person has a right to decline having anything injected, by any means, into their body without their approval. After all the injuries we’ve endured, the local health department is still pushing the patients to get their shots up to date. I am appalled and sickened!!!

Another point that’s being brought to the forefront by Robert F. Kennedy, Jr. was that the childhood vaccines are not the life savers they are touted to be. A group of mothers brought to his attention that he needed to investigate the ingredients and the frequency of the childhood vaccines. He had already been involved with chemical contaminants so he looked into vaccines. He found that the shots included fetal DNA (cells from aborted babies), aluminum, mercury (thimerosal), genetically modified yeast, bacterial and viral DNA, Monosodium Glutamate (MSG), Polysorbate 80 & 20, and formaldehyde (formalin). These ingredients can cause and are linked to Alzheimer’s Disease, brain damage, seizures, organ damage, genetic mutations, developmental delays and infertility, cancer and death. The polio vaccine in the 50’s contained monkey cells (SV-40), which carried strains of monkey diseases as well as cancer. The book *Make an Informed Decision*, Mayer Eisenstein, M.D. shares information about this and other vaccines

The fact that childhood vaccines contain dangerous ingredients was serious enough, but then there is the fact there have NEVER been any clinical tests when combined into MMR, DPT, etc. If these combinations included several of these poisons, is it any wonder America has the highest SIDS deaths along with the highest ‘well baby’

vaccinations and sicker kids overall?

In 1986 President Reagan reluctantly signed a Bill “protecting pharmaceutical companies that produce vaccines from ALL liability for vaccine-related side effects and deaths, after hundreds of lawsuits from vaccine victims flooded the courts. This means you CANNOT sue vaccine makers for side effects and injuries, even in the case of death.” *LearnTheRisk.org* This law needs to be repealed. In 1960 the CDC recommended 5 doses; 1983 saw an increase to 24 doses; and in 2019 they have 72 doses. \*cdc.gov

A Michigan mom and dad of triplets told of the fate of their babies after their ‘well baby’ visit. Before the shots all three would sit on the floor side by side and hold hands and make baby sounds. After that fateful appointment, they were never the same.
