Pro-Life Activist Sentenced to Over Three Years in Prison Under FACE Act by Biden DOJ

Bevelyn Beatty Williams, a pro-life activist, was sentenced to 41 months in federal prison under the FACE Act for blocking entrances to a New York abortion facility while preaching the Gospel.

Williams claims her imprisonment is politically motivated and criticizes the Biden-Harris administration for targeting pro-life activists, particularly Christians, using the FACE Act to maximize convictions.

Her appeal was denied in July 2024 by a Biden-appointed judge, and she has expressed that her activism and ministry will continue even from prison.

CBS News is facing an FEC complaint for allegedly selectively editing Kamala Harris’s interview on 60 Minutes to make her appear more coherent, sparking accusations of election interference.

A House Homeland Security report revealed that Chinese Communist Party (CCP) espionage activities have “expanded rapidly” across 20 U.S. states since the Biden-Harris administration took office.
